## Point Rencontre Vaud : health measures and rules of behaviour

The organisation of the visits may vary according to the configuration of the premises and the evolution of cantonal and federal directives. In the event of non-compliance, the visit may be interrupted and the person(s) invited to leave the premises.

Each parent concerned is expected at the place and at the time established in advance. The organisation and security measures could cause inconveniences, including delays. Therefore, we kindly ask you to comply with the following instructions and those available on site. This helps to limit the time needed for transitions (arrivals and departures). Point Rencontre is not authorised to make any changes to the terms of the orders, except for those aspects that fall within our competence according to internal regulations or health requirements.

The Regional Managers of Point Rencontre are at your disposal for further information and to answer any questions you may have.

### Rules and measures applied

- Indoor visits:** as far as possible, for visits which take place indoors only, the lodging parents are requested to stay in the reception area provided for this purpose and not to move around in areas where limited indoor visits only take place ;
- Outdoor Visits:** For Outings and Passages (outdoor visiting rights), as far as possible, host parents and visitors are requested to stay in the reception area provided for this purpose (as far as possible, circulation in areas intended for indoor visits is not allowed).
- At reception:** Point Rencontre interviews parents and children to make sure that they are asymptomatic (dry cough and/or sore throat, fever, even loss of smell) and have not come into contact with a person suspected of CoVid-19 (same symptoms) or having tested positive during the 10 days preceding the visit to Point Rencontre. Apart from obvious symptoms, this verification is based solely on the good faith of the interviewees.  
According to the above indications, in the following cases, the visit will not be carried out through the intermediary of Point Rencontre and access to the visiting premises will be refused:
  - Presence or description of symptoms in adults or children (regardless of age).
  - Adult who has been in contact with a person suspected of CoVid-19 or who has tested positive.
  - Child who has been in close contact in the family sphere (indoor/outdoor) with a person suspected of or testing positive for CoVid-19.
  - Children over 12 who have been in contact in their social environment (school, leisure activities, etc.) with a person suspected of or testing positive for CoVid-19.
- Wearing a mask during visits:** Mask available, compulsory for adults and children from 12 years old (movement in the visiting area and reception). Wearing of the mask is optional in the open air, except in the case of groups of people and queues. Once the participants have settled around the table and the visit has begun, the mask can be removed without putting it on the furniture.
- Hand washing:** obligatory for everyone during indoor visits.
- Hand disinfection:** compulsory for all, adults and children (on entry and exit).
- Distances:** keep social distance. Respect the social distance in any queues.
- Distances between children and between children and parents:** no restrictions, but caution and rigour.
- Play equipment and toys:** these are no longer provided. The parent is encouraged to bring the child's personal games and toys.
- Beverages:** Hot or cold drinks are no longer made available. Personal drinks are freely allowed.
